Acknowledgement of Risks

- Inclement weather including but not limited to wind, rain, lightning, hail, snow, extreme temperatures.
- Participants sense of balance, physical coordination, ability to operate equipment, swim and/or follow directions.
- Collision, capsizing, sinking or other hazards which result in wetness, injury, exposure to the elements, hypothermia, and/or drowning.
- The presence of insects, animals, and marine life forms. Allergies to any plant form or animal/insect.
- Equipment failure or operator error under any circumstances.
- Heat or sun related injuries or illness, including but not limited to sunburn, sunstroke or dehydration.
- Fatigue, chill and/or dizziness which may diminish participant's reaction time and increase the risk of an accident.

Express Assumption of Risk and Responsibility

I and all in my party agree to assume responsibility for all the risks of the activity, whether identified above or not (even those arising out of the negligence of Riverside Canoe).
